Purpose

This procedure is intended to allow you to raise a concern or complaint relating to the school, or the services that it provides.

This complaints procedure is not limited to parents or carers of children that are registered at the school. Any person, including members of the public, may make a complaint to Willerby Carr Lane about any provision of facilities or services that we provide. Unless complaints are dealt with under separate statutory procedures (such as appeals relating to exclusions or admissions), we will use this complaints procedure.

The Local Authority does not investigate complaints directly. If a complaint is made either in writing or verbally to the Director of Children, Family and Adult services or to any officer of the Local Authority, the Governing Body of the school is made aware of the complaint and is requested to deal with it through the adopted procedure. *An anonymous concern or complaint will not be investigated under this procedure, unless there are exceptional circumstances.*

To enable a proper investigation, concerns or complaints should be brought to the attention of the school as soon as possible. In general, any matter raised more than 3 months after the event, being complained of, will not be considered. Any complaints that are sent to the school during school closure times (any periods when the children are not in school, including weekends and holiday periods) will be dealt with as if they were received on the first day that the school reopens.

The difference between a concern and a complaint

A 'concern' may be defined as 'an expression of worry or doubt over an issue considered to be important for which reassurances are sought'.

A complaint may be generally defined as 'an expression of dissatisfaction however made, about actions taken or a lack of action'.

It is in everyone's interest that concerns and complaints are resolved at the earliest possible stage. Many issues can be resolved informally, without the need to invoke formal procedures. At Willerby Carr Lane Primary School, we take informal concerns seriously and make every effort to resolve the matter as quickly as possible.

The Headteacher (or Chair) may ring you or invite you to a meeting to clarify your concerns and to explore the possibility of an informal resolution. If you accept that invitation, you may be accompanied by a friend, if you wish, to assist you in explaining the nature of your concerns.

In most circumstances complaints will be resolved through a meeting with the Headteacher (or chair). If not, arrangements will be made for the matter to be fully investigated, using the appropriate procedure. In any case you should learn in writing, usually within 5 days of the school receiving your formal complaint, of how the school intends to proceed. This notification should include an indication of the anticipated timescale.

There are occasions when complainants would like to raise their concerns formally. In those cases, the school's formal procedure should be invoked through the stages outlined below.

Raising a concern or complaint

1) Informal Stage

It is normally appropriate to communicate directly with the member of staff concerned. This may be by letter, by telephone or in person by appointment, requested via the school office. The school will ask you at the earliest stage what you think might resolve the issue. Many concerns can be resolved by simple clarification or the provision of information, and it is anticipated that most complaints will be resolved by this informal stage. Where this action does not lead to the problem being resolved informally, then the complaint should be dealt with through the formal stages of this procedure.

In the case of serious concerns, it may be appropriate to address them directly to the Headteacher. If the Headteacher is the subject of the complaint, it should be addressed to the Chair of Governors c/o the school and marked 'confidential'. If the complaint is about the Chair of Governors or any individual governor, it should be made to the Clerk of the Governing Body.

2) Formal Stage

If your concern or complaint is not resolved at the informal stage you, may choose to put the complaint in writing and pass it to the Headteacher, who will be responsible for ensuring that it is investigated appropriately. You may also request to speak to the Headteacher on the phone.

If the complaint is about the Headteacher, your complaint should be passed to the school office, addressed for the attention of the Chair of the Governing Body and marked 'confidential'.

If the complaint is about the Chair of the Governing Body or any individual governor, it should be addressed to the Clerk to the Governing Body, c/o the school and marked 'confidential'.

Please note that a telephone message can also be passed to the Chair or Clerk through the school office, who will call you back.

You should include details which might assist the investigation, such as names of potential witnesses, dates and times of events, and copies of relevant documents. It is very important that you include a clear statement of the actions that you would like the school to take to resolve your concern. Without this, it is much more difficult to proceed.

Note: The Headteacher may delegate the investigation to another member of the school's senior leadership team, but will not delegate the decision to be taken.

Any investigation will begin as soon as possible and when it has been concluded, you will be informed in writing of its conclusion. If you are not satisfied with the manner in which the process has been followed, you may request that the governing body reviews the process followed by the school, in handling the complaint. Any such request must be passed to the Chair of the Governing Body via the school office, marked 'confidential', within 10 school days of receiving notice of the outcome, and include a statement specifying any perceived failures to follow the procedure.

During the investigation, the Headteacher or delegated SLT member (or independent investigator) will:

- if necessary, interview those involved in the matter and/or those complained of, allowing

them to be accompanied if they wish

- keep a written record of any meetings/interviews in relation to their investigation.

At the conclusion of their investigation, the Headteacher will provide a formal written response within 5 school days of the date of receipt of the complaint.

If the Headteacher is unable to meet this deadline, they will provide the complainant with an update and revised response date.

The response will detail any actions taken to investigate the complaint and provide a full explanation of the decision made and the reason(s) for it. Where appropriate, it will include details of actions Willerby Carr Lane Primary School will take to resolve the complaint.

The Headteacher will advise the complainant of how to escalate their complaint should they remain dissatisfied with the Formal stage outcome.

If the complaint is about the Headteacher, or a member of the governing body (including the Chair or Vice-Chair), a suitably skilled governor will be appointed to complete all the actions in the formal stage.

Withdrawal of a Complaint

If a complainant wants to withdraw their complaint, we will ask them to confirm this in writing.

Governing Body Meetings

a) Complaints panel

If the school receives a formal complaint about one of the limited number of matters, that is not dealt with by another statutory process, it may be necessary to convene a governing body panel to consider the matter and formulate a response. The complaint is likely to relate to matters such as:

- the content or the application of a governing body policy;
- school facilities;
- services that the school provides.

If a governing body committee already has delegated power with respect to a policy that is being complained of, a panel of members from that committee should be convened. Otherwise, the chair should convene a panel of 3 governors, who have not previously been involved with the complaint.

The complainant should submit the details of their concerns, in writing, to the chair. The chair will seek similar written responses from the school, where this is necessary. The complainant may also request to submit their complaint verbally.

A meeting of the panel will take place, usually within 10 school days, to consider the matter. The complainant (who may be accompanied by a friend if they wish) and representative(s) from the school (who may also be accompanied by workplace colleagues or representatives from their professional associations) may be invited to attend this meeting in order to clarify the matter. As the panel meeting is intended to be investigatory, rather than adversarial, the persons giving evidence or making representations to the panel will normally attend separately.

When the panel has collected sufficient information, it will deliberate and then inform the complainant, the Headteacher and the governing body of the outcome, in writing.

The letter to the complainant will include details of how to contact the Department for Education if they are dissatisfied with the way their complaint has been handled.

The response will detail any actions taken to investigate the complaint and provide a full explanation of the decision made and the reason(s) for it. Where appropriate, it will include details of actions Willerby Carr Lane Primary School will take to resolve the complaint.

The response will also advise the complainant of how to escalate their complaint should they remain dissatisfied.

Consideration of the complaint by the governing body and the school, save for any actions that are agreed, will terminate at this point.

Complaints Not in the Scope of the Procedure

The complaints procedure covers all complaints about any provision of facilities or services that we provide with the exceptions listed below, for which there are separate (statutory) procedures.

Unreasonable complaints

The school has a separate policy to manage serial and persistent complainants.

The Role of the School Complaints Unit

If a complaint has completed the local procedures and the complainant remains dissatisfied, they have the right to refer their complaint to the Secretary of State. The Secretary of State has a duty to consider all complaints raised but will only intervene where the governing body has acted unlawfully or unreasonably and where it is expedient or practical to do so.

The School Complaints Unit (SCU) considers complaints relating to LA maintained schools in England on behalf of the Secretary of State. The SCU will look at whether the complaints policy and any other relevant statutory policies were adhered to. The SCU also looks at whether statutory policies adhere to education legislation. However, the SCU will not normally re-investigate the substance of the complaint. This remains the responsibility of schools.

The SCU will not overturn a school's decision about a complaint except in exceptional circumstances where it is clear the school has acted unlawfully or unreasonably. If the SCU finds that the school has not handled a complaint in accordance with its procedure, we may request that the complaint is looked at again.
